- Diploma / BSc./ITI in Branch / Subjects as specified above will ONLY be considered as eligible qualification.

- Minimum 18 years and Maximum age shall be 27 years for General candidates as on 01.08.2023.
- Relaxation in age up to 5 years for SC/ST, 3 years for OBC (NCL), for IFFCO deceased employee dependent 3 Year will be allowed.
