IV. PERIOD OF CONTRACT APPOINTMENT:

1. The tenure of contract appointment will be 1-3 years.

V. CONDITIONS:

1. Retired personnel means i.e. from Railway, Railway PSU, Metro Railway, CPWD, Govt. PSU, Govt. Utility service department and shall produce required relevant supporting documents for verification at the time of interview.
