#### **General Conditions**

- 1. All qualifications should be from Universities/Institutions recognized and approved in India by AICTE/ UGC / appropriate statutory authority.
- 2. Candidates belonging to Central Govt./ State Govt. / PSU/ Public Sector Banks/ Autonomous bodies shall normally submit their application through proper channel. However, in the event of difficulty in getting NOC, they may submit their application through online directly and they will shall produce NOC later from their organization, in case they are shortlisted for selection process.
- 3. Applications lacking supporting documents, incomplete data or received late will be summarily rejected.
- All computations of age/minimum experience requirement/qualification shall be done w.r.t October 14, 2022 (last date of advertisement). The date of declaration of result/issuance of mark sheet shall be deemed to be the date of acquiring the qualification and there shall be no relaxation on this account.
