TERMS AND CONDITIONS FOR THE POST OF ENGINEER GR. II ON CONTRACT BASIS.

- **I. Qualification:** The candidate shall possess the following qualifications:
 - a) NCV Class IV (Motor) Certificate of Competency issued by the MMD.
 - b) Working experience of minimum 2 years in vessels of more than 2400 KW (or 3218 HP) and candidates having port service experience will be preferred.

II Working hours: The duration of working hours for the Engineer on contract basis will be 08 hours per day, with one day weekly off in 7 days. He has to work onboard tugs in shift duties in accordance with the instructions and directions of the Deputy Conservator, NMPA. If duty performed beyond 8 hours or on weekly off days, he would be entitled for overtime payment as applicable to NMPA staff

III Monthly Remuneration:

- (a) The consolidated pay for Engineer Gr. II on contract basis is Rs. 60,000-00.
- (b) An increment of 5 % on consolidated monthly of remuneration would be considered for every completed year of service, subject to satisfactory performance. If the Engineer opts to avail port quarters, Rs.3,500-00 per month would be deducted from the total monthly emoluments.
- (c) In case of re-engagement of retired officials, the remuneration shall be fixed as per Government guidelines.

IV Leave entitlement: He is entitled for 20 days Casual Leave per year at the rate of 05 days Casual Leave for every 03 completed months of service to the Engineer Gr. II on contract. The non-availed causal leave can be carried forward to the following year. However, the casual leave cannot be accumulated more than 20 days.

If he avails himself of leave in excess of his casual leave entitlement or absents himself from duty without leave on any day, deduction of a sum proportionate to the period of such absence will be made from the total monthly remuneration payable to him by calculating on the basis of the said monthly remuneration divided by 30 for each day of such absence.

V. Medical Facility: The selected candidates shall be entitled for free medical treatment in NMPA hospital for self with dependent spouse and children to the extent the facilities available in the port hospital.

VI. Tenure of the Engagement: The tenure of the engagement shall be for a period of 03 years from the date of joining the duty/service.

VII. Security Bond: He shall execute a security bond (in the specimen attached herewith) to the effect that he will serve in the NMPA as an Engineer Gr. II on contract basis for a period of 03 years from the date of joining the duty /service.

VIII. TA/DA for Tour Travel: As and when required to be deputed on official tour for the purpose of work, he will be entailed to draw TA/DA as applicable to the category of the post held by him, with prior approval of the Chairperson on each occasion, obtainable through Deputy Conservator, New Mangalore Port Authority. However, whenever he is deployed to proceed on voyage by floating crafts to perform temporary duties at places away from this port's limits, he will be entitled to draw Voyage Allowance and Outstation Allowance at the applicable rates, in lieu of TA/DA. He will be entitled to draw the Voyage Allowances and Outstation Allowances with prior approval of the Chairperson on each occasion, obtainable through the Deputy Conservator, New Mangalore Port Authority. No TA/DA will be paid for joining for duty in response to this offer.

IX. Accommodation: He will be permitted to occupy the port Quarters if he opts for the same. The class of accommodation that would be allotted to him shall commensurate with the post held by him subject to availability of vacant quarters. However, proportionate deductions will be made from the monthly consolidated salary payable to him as mentioned herein before. In addition, allied charges such as the license fee, water charges and electricity charges will have to be borne by the occupant.

X. Other Service Benefits: For the purpose of attributability for the injuries sustained by him during his course of duty, the Engineer Gr. II on contract basis will be treated as an employee of the New Mangalore Port Authority only during his duty hours.

XI. Termination of Contract: His engagement as an Engineer gr. II on contract basis can be terminated by either side by giving one month's notice during the currency of contract.

XII. Claim for permanent absorption: The contract engagement shall not confer on him any right to lay claim to permanent absorption in the port service against any post whatsoever.

XIII. Settlement of Disputes: In the event of any dispute arising out of this contract, the interpretation and decision of the Chairperson, New Mangalore Port Authority will be final and binding.

If the candidate is amenable to the terms and conditions set out above, he/she will be required to execute a security bond in the format given herewith for the period of engagement as an Engineer Gr. II on contract basis and join for duty on the stipulated date. On the other hand, if he/she is not in a position to join for duty by the said date, he/she must send necessary communications duly intimating the date by which he/she will be able to join for duty as Engineer Gr. II on contract basis at this Port. If he/she fails to comply with both the options, this offer will stand cancelled.

In addition to the above, the contract Engineer Gr. II must take note of the fact that his/her engagement to the post of Engineer Gr. II contract basis shall be subject to his being medically fit for the duties to be performed in the said post. Therefore, the candidate selected for engagement as Engineer Gr. II on contract basis will, at the first instance, have to report to the Chief Medical Officer of the New Mangalore Port Authority Hospital to undergo necessary medical examinations prior to joining duty as Engineer Gr. II on contract basis at this Port.
