NOTIFICATION

Applications are invited from the eligible candidates to fill (17) MLHP posts in Health Wellness centers under National Health Mission under 15th Finance commission in Mahabubnagar District on Contract Basis from 27.01.2024 to 31.01.2024 for a period of one year and it will be extended subject to satisfaction of their services. The qualification and remuneration of posts are mentioned below against each category.

Following are the main guidelines and instructions for fill up the positions of Community Health Officer/Mid Level Health Providers (MLHP).

- ➤ Recruitment shall be done for (17) of Mid-Level Health Providers (MLHP) vacancies at Sub-Centre to be converted as Health & Wellness Centers in state.
- ➤ **APPLICATION:-** may be invited by the respective District Selection Committee headed by the District Collector from eligible candidates.
- > SELECTION SHALL BE DONE FOR MLHP POSTS AS PER THE FOLLOWING PRIORITY:-
- (i).MLHP Posts of sub Centre (HWCs) That are located in municipal areas should be filled with MBBS/BAMS doctors only with reference being given to MBBS Doctors/BAMS doctors only with preference being given to MBBS doctors.
- (ii).MLHP posts of Sub Centre (HWCs) that are located in other than municipal areas, the recruitment shall be done in the following orders of priority.
- (a).doctors (MBBS/BAMS) with preference being given to MBBS.
- **(b).**Staff Nurse with B.Sc (Nursing) who are graduate from the academic year 2020 onwards (or) staff nurse with B.Sc (Nursing)/GNM who graduate before the academic year 2020 and who completed 6 months bridge programme in Community Health (CPCH).
- In the Health and wellness centers located in municipal areas, the positions will be first filled up with MBBS doctors as per eligibility, after exhausting the MBBS, these vacancies will be filled with BAMS doctors as per eligibility.
- In the Health and wellness centers located in non-municipal areas the positions will be first filled up with MBBS doctors as per eligibility, after exhausting the MBBS doctors, these vacancies will be filled with BAMS doctors as per eligibility, if no doctors are available, then these positions can be fill up by staff nurses as per eligibility.
- ➤ AGE:- as prescribed by government vide G.O.Ms.No.42, Gen.Admin (Ser.A) Dept, Dt.19.03.2022 the minimum and maximum age in 18 years and 44 years respectively. The upper age limit prescribed above however relaxed in the following cases:

The minimum age is 18 years and the maximum age is 44 years.

The minimum and maximum age shall be reckoned as on 01.07,2023 with the following reservation allowed for reckoning the maximum age limit as per rules in force:

RULE OF RESERVATION:-

(I)Rule of Reservations in respect of Community, Disability, Ex-Service Men/Women shall be strictly observed as ordered by the Government of Telangana from time to time.

(II)The Rule of Reservations to local candidates is applicable as per the Presidential order.

(III)The districts should continue the existing Roster.

(IV)The vacancies for the posts mentioned in G.O.68, falling in Scheduled Areas should be filled exclusively with the Local Scheduled Tribes.

SELECTION WILL BE DONE ON MERIT:-

Selection will be done on following criteria:

- (I) Merit Lists shall be prepared separately for each of the categories of Posts.
 - (a) The Selection to the Positions shall be done by exhausting all the eligible candidate from Merit List of Medical Officer MBBS.
 - (b) After Exhausting the Selection from the Merit List of Medical Officer, the Vacancies shall be filled by he eligible candidate from the Merit List of Medical Officer-AYUSH.
 - (c) After Exhausting the Selection from the Meirt List of Medical Officer-AYUSH, the remaining vacancies shall be filled by the eligible candidates from the merit list of Bsc Nursing (Community Health).
- (II) Total marks are 100 of which 90 marks will be allotted basing on the marks obtained in qualifying examination and 10 marks will be awarded for age. Weight-age for age will be reckoned from 18 years of age of the candidate. 0.5 marks will be awarded for one completed year with a maximum of 10 marks. The age will reckoned as on 01.0.2021 (example 1 if a candidates completes 20 years as on 01.07.2021, she/she will be awarded 1.0 marks:, Example 2. If a candidate completes 30 years of age as on 01.0.2021, he/she will be awarded 6.0 marks: Example 3. If a candidate completes 40 years of age as on 01.07.2021, he/she will be awarded 10.0 marks).
- (III) Merit will be prepared based on the marks obtained with above criteria and displayed on official Website of Dist Collector, for transparency and also for calling objections.
- (IV) Selection list will be prepared form the finalized merit list dully following the Rule of Reservation (ROR) and Presidential Orders.,
- (V) It shall be noted that these Positions are not transferable.

HOW TO APPLY:-

- (I) Application forms along with instructions can be downloaded from the official Website of the respective District.
- (II) Filled in application forms shall be submitted in persons or though Register post to the respective Dist Medical & Health Officers of the District which the candidates is applying. Applicants which are received after due date will be summarily reject, District Selection Committed is not Responsible for postal delays.
