1.	New defined contributory pension scheme as introduced vide government vernacular resolution dt.18/03/2005 and 06/06/2005 No.NPN-2003-GOI-10-P will be applicable to the appointees other than employees of erstwhile Gujarat Agricultural University.
2.	The employee of erstwhile Gujarat Agricultural University shall be entitled for the pay protection and service continuation as per university rules.
3.	The post of SC, ST, SEBC, EWS, PwD and Women will be filled up as per State Govt. reservation rules. <u>The reservation of posts is for the candidates of Gujarat State origin only, therefore the candidates of other states need not to apply for the reserved posts.</u> In case of non-availability of women candidates, the posts so reserved will be allotted to the male candidate of the same category. In case of non-availability of PwD candidates, the posts will be filled by available candidates.
4.	Along with application, SEBC candidate must have to submit "Non-Creamy Layer Certificate" in the prescribed format issued (from dt.01/04/2022 to the last date of application submission i.e. dt.23/01/2025) by competent authority of Gujarat State with validity as per the resolution No. SSP/122015/455246/A dt.26/04/2016 issued by Department of Social Justice & Empowerment, Government of Gujarat, Gandhinagar, failing which, the candidate will not be entitled to get the benefit of reserved category.
5.	Certificates for eligibility for reservation in favour of EWS category shall be issued (from dt.24/01/2022 to the last date of application submission i.e. dt.23/01/2025) in the format as prescribed by Social Justice and Empowerment Department, Government of Gujarat's resolution No: EWS/122019/45903/A, Date:25/01/2019 and G.R. The candidates shall mention the Number and date of EWS Certificate while applying online. 7.	Age relaxation in case of SC, ST, EWS, PwD, SEBC and Women candidate as per the prevailing rules of Government of Gujarat.
8.	The University will verify the antecedents or documents submitted at any time, at the time of appointment or during the tenure of the service. In case, it is found that the documents submitted are fake or the candidate has clandestine antecedents/ background and has suppressed the said information, his/her service shall be terminated forthwith.
9.	Candidate should be a citizen of India. or should possess the nationality as provided in Rule-7 of the Gujarat Civil Service Classification and Recruitment (General) Rules, 1967.

11.	Possess the basic knowledge of computer application as per Government of Gujarat rules. If the candidate without having passed CCC+ examination is selected, he / she will have to pass the said examination during the probation period, failing which, his / her probation period will not be regularized.

3. Surname must be filled in the block provided for the Last Name, Father's name or any of the middle names if given in the SSC certificate must be filled in the Middle Name and candidates own name must be filled in the first name.
