**Recruitment for the posts of Lecturers in various subjects and Foreman Instructor (Group-B) in Higher Education Department (Directorate of Technical Education), Advt. No. 72 to 87/2024.**

## Corrigendum-I

The Commission had advertised 237 posts of Lecturers in various subjects and Foreman Instructor (Group-B) in Higher Education Department (Directorate of Technical Education), vide advertisement No.72 to 87 of 2024 followed by announcement dated 11.11.2024. The Government has issued Notification No. 22/163/2024-5HR-II dated 13.11.2024 regarding sub categorization of Scheduled Castes of Haryana. This Corrigendum is being issued in view of the said notifications issued by the Government.

### A. Notification No.22/163/2024-5HR-II dated 13.11.2024

In view of Government of Haryana notification No.22/163/2024-5HR-II dated 13.11.2024, the Additional Chief Secretary to Govt. Haryana, Higher Education Department, Haryana has sent a revised requisition vide memo no. 44/03/2023-II-तकशिशि0 dated 10.01.2025, which is as under:-

In view of the above, it has been decided to re-open the online application portal from **04.02.2025 to 19.02.2025** for the following:-

**1. SC candidates who have already applied:-**

All the candidates of Scheduled Caste category who have already applied in response to advertisement dated 06.11.2024 followed by announcement dated 11.11.2024 are directed to update their online application form and mention their respective category as DSC or OSC as the case may be. Further all the candidates who now come in DSC category are directed to submit/upload the latest DSC category certificate issued as per notification No.22/163/2024-5HR-II dated 13.11.2024. In case of OSC category candidates, their already uploaded SC certificate would be considered. After updation of information, please download a copy of the same & read it carefully. After checking the correction of the information, sign it & upload the same.

**2. DSC and OSC Candidates applying in response to this corrigendum:-**

All the candidates of DSC and OSC category who had not applied earlier and are now applying after issuance of this corrigendum, would be required to submit online application form clearly mentioning their category as DSC or OSC and they would be required to upload their latest DSC/OSC (SC) certificate issued by the competent authority along with the online application form.

**3. The SC candidates who had already submitted their online applications but they could not upload the duly signed application form after taking out the printout or had erroneously filled wrong particulars relating to their category, qualification etc. in their previous application form, such candidates would have to cancel their already filled application form and then submit fresh application form by paying the requisite fee. The fee already paid with the earlier application form will not be adjusted against the new application form.**

4. The SC candidates who have already applied in response to advertisement dated 06.11.2024 but as per revised requisition no post is available under their sub-category DSC or OSC as the case may be, the candidature of such candidates will be considered under General category.

**B. BC-A (Non-Creamy Layer), BC-B (Non-Creamy Layer) and EWS Candidates.**

**1. BC-A, BC-B and EWS candidates who are applying in response to this Corrigendum:-**

- (a) All the candidates belonging to BC-A (Non-Creamy Layer), BC-B (Non-Creamy Layer) category applying in response to this Corrigendum would have to upload a certificate on the online portal which has been issued as per Haryana Government instructions No. 22/132/2013-IGS-III dated 22.03.2022, Government notification No. 40/13/2024-1SW dated 16.07.2024 and as amended from time to time. **This certificate should be issued in & after 16.07.2024 and before the closing date & as per Government of Haryana notification dated 16.07.2024. Certificates issued prior to 16.07.2024 or after the closing date of corrigendum would not be considered.**
- (b) Similarly the EWS category Candidates applying in response to this Corrigendum are required to upload a certificate on the online portal which has been issued as per Haryana Government instructions issued vide No. 22/12/2019-1GS-III dated 25.02.2019. **This certificate should be valid for the financial year 2024-2025 and should be issued after 01.04.2024 and before the closing date. Certificates issued prior to 01.04.2024 or after the closing date of corrigendum would not be considered.**

**2. BC-A, BC-B and EWS candidates who have already applied:-**

- (a) The candidates of BC-A (Non-Creamy Layer), BC-B (Non-Creamy Layer) and EWS who have already submitted their online application in response to Advertisement No. 72 to 87 of 2024 are directed to submit a fresh certificate on the online portal. After updation of information, please download a copy of the same & read it carefully. After checking the correction of the information, sign it & upload the same.

**C. ESM/DESM category candidates**

**1. ESM/DESM Candidates who have already applied :-**

- (a) The candidate belonging to ESM category who have already submitted their application in response to Advertisement No 72 to 87 of 2024 are directed to upload copy of their Identity Card issued by Zila Sainik Board. The ESM ID Card No., Date of Issue of ESM ID Card and Date of Discharge from service should be entered in the online application portal.
- (b) The candidate belonging to DESM category who have already submitted their application in response to Advertisement No 72 to 87 of 2024 are directed to upload their Eligibility Certificate issued by Zila Sainik Board. The Serial No. of eligibility

register, date of issue of the DESM certificate and details regarding renewed upto be entered in the online application portal.

2. ESM/DESM Candidates who are applying in response to this Corrigendum


(a) The candidate belonging to ESM category who are applying in response to this Corrigendum are directed to upload copy of their Identity Card issued by Competent Authority/Zila Sainik Board. The ESM ID Card No., Date of Issue of ESM ID Card and Date of Discharge from service should be entered in the online application portal.

(b) The candidate belonging to DESM category who are applying in response to this Corrigendum are directed to upload their Eligibility Certificate. The Serial No. of eligibility register, date of issue of the DESM certificate and details regarding renewed upto be entered in the online application portal.

**Note:-**

1. The other terms & conditions mentioned in the advertisement No. 72 to 87 of 2024 dated 06.11.2024 shall remain unchanged and would be applicable. The candidates are directed to read all the terms and conditions carefully before submitting their online application forms.
2. The candidates who have not applied earlier in response to Advertisement dated 06.11.2024 can also apply against this corrigendum.
3. The candidates who have applied earlier against advertisement No. 72 to 87 of 2024 but could not upload the dully signed application form after taking out the printout or they had erroneously filled wrong particulars relating to their category, qualification etc. in their previous application form, all such candidates are directed to apply afresh through online mode only, after cancelling their previous application form and filling new application form after payment of requisite fee.
4. **The candidates who have not applied earlier, but are applying fresh against this corrigendum their age and educational qualification and certificates of BC-A(NCL)/BCB(NCL)/EWS/ ESM/DESM etc. will be determined on the last date of Corrigendum i.e. 19.02.2025.**
